Master's Thesis Committee Requirements

- 1. The chair or one of the co-chairs of the committee must be from Column 1 or Column 2 (commonly the grad student's Advisor)
- 2. The committee must have at least three members
- 3. Two of the committee members must be UW-Madison graduate faculty (Columns 1 and 2)
- 4. The third member and any additional members may be: graduate faculty, faculty from a department without a graduate program, academic staff, emeritus faculty, visiting faculty, faculty from other institutions, scientists, research associates and other individuals deemed qualified. Anyone above qualifies
- 5. Committees are approved by the Director of Graduate Studies for the Department of Animal and Dairy Sciences
- 6. All committee members have voting rights

Doctoral Committee Requirements

- 1. Up to three of the committee members may be graduate faculty in the Department of Animal and Dairy Sciences (Column 1)
- 2. The chair or one of the co-chairs of the committee must be from Column 1 or Column 2 (commonly the grad student's Advisor)
- 3. The committee must have at least four members
- 4. The committee must have members from at least two UW-Madison graduate programs. (Column 2 qualify)
- 5. The fourth and any additional members may be from: graduate faculty, faculty from a department without a graduate program, academic staff, emeritus faculty, visiting faculty, faculty from other institutions, scientists, research associates and other individuals deemed qualified. Anyone above qualifies
- 6. Committees are approved by the Director of Graduate Studies for the Department of Animal and Dairy Sciences
- 7. Three committee members must be designated as readers
- 8. All committee members have voting rights
